
### OUR ORGANISATION

# JUSTICE IN WALES FOR THE PEOPLE OF WALES

The report of the Commission on Justice in Wales, published in October 2019, found that "the people of Wales were being let down by the system in it's current state". It found:

"The significant cuts to legal aid made in 2012 have hit Wales hard. Proper access to justice is not available with the consequent threat to the rule of law."

The review of the justice system by the Commission was the first in 200 years and set a long-term vision for its future. It identified a need for a mixed economy of legal aid, third sector and pro bono advice and assistance.

We believe that a Law Centre is an essential part of this mixed economy. 07

## THE LAW CENRE MOVEMENT

LAW CENTRES HAVE EXISTED SINCE THE EARLY 1970S AND WORK WITHIN THEIR COMMUNITIES TO DEFEND THE LEGAL RIGHTS OF LOCAL PEOPLE.



Specialising in social welfare law, they have an in-depth knowledge of the issues communities face. They use this knowledge to help people save their homes, keep their jobs and protect their families.

ABOVE ALL, LAW CENTRES EXIST TO IMPROVE THE DAILY LIVES OF THE COMMUNITIES THEY WORK IN.

Law Centres offer legal advice, casework and representation to individuals and groups. Spotting local trends and issues in the course of their work, they highlight them to bring about necessary policy changes and to prevent future problems. Law Centres also help build capacity within communities by training and supporting local groups and educating people about the law and their rights.

### OUR PROGRESS



THIS SECTION INCLUDES THE PROJECT'S INCEPTION, IMPLEMENTATION, AND EXECUTION.

- 2018 A group of practicing lawyers and advice workers, from North Wales and across the UK, meet on a trip to Snowdonia and discuss access to justice in the region.
- 2019- Law Centres Network provide seed funding to explore developing provision in North Wales. The Steering Group forms and meets remotely to discuss what a Law Centre in North Wales might look like and how to make it happen.
- 2022 The Steering Group is awarded funding for a 1-year Development Phase. The Development Manager is recruited. We are awarded significant grants to launch the Law Centre and part-fund the first three years.
- **2023** We apply for our first Legal Aid contract, the Solicitors Quality Mark, and begin recruiting our team ready to open our doors in Summer 2023.

n response to our research and the needs we've identified, our Law Centre will initially provide specialist legal advice in housing and domestic abuse matters.

Our delivery model includes in-person and digital outreach services in rural locations across North Wales.

The Law Centre shares a building with Aberconwy Domestic Abuse Service, an established, welcoming and well equipped space in a strategic location.

Basing outreach work within trusted community spaces such as foodbanks and libraries ensures we are firmly rooted in communities we serve.

Working in partnership our caseworkers and solicitors will provide as seamless a service as possible, developing skills and experience across relevant areas of law. The service will be available to people across North Wales, and respond to the particular needs we see in the community as the service develops.
